2023 Activities Report

2023 TOTAL funding spent in priority areas in the LSC: \$3,360,522

WBIF: \$672,472 Non-WBIF Funds: \$2,688,050

Total amount of phosphorus reduced in priority waterbodies in 2023: 6,152 lbs/yr


