Local Decision Makers

- Adopt a Drain Updates:
 - Chisago County (official membership established in May 2022)
 - Working to get additional communities storm maps added to official Adopt a Drain site
 - Harris added beginning of September, working currently with Wyoming
 - Spoke at senior living development about importance of drain adoption (they adopted almost 15 drains!)
 - Working with member of Chisago City parks commission to build awareness of program at various events and local leader meetings
 - Working with regional library director to put together small displays in all regional libraries

Network Building

- Holding monthly ag team meetings to provide updates, collaborate, and plan with the partners
- Offering weekly "office hours" for ag staff across the LSC basin to drop in and ask questions
- Working with partners to create a contact and tracking spreadsheet (Angie and Barbara)
- Attended and presented at the Minnesota Farm Bureau's Board of Directors meeting on July 27th, discussing the programs and services provided to the watershed farmers
- Attended the Workshop at the Winery to connect with local decision makers about water quality and watershed scale planning
- Developed a contact list for small acreage farmers in the watershed and developing programming to support this clientele
- Working with South Washington Watershed District to develop connections with agricultural producers in their watershed
- Talking one on one with producers to build connections between farmers and partners and begin the development of local farmer groups and farmer mentors

• Developed, submitted, and secured a scholarship and mini-grant proposals for field days and secured funding for the field days through a sponsorship with the MAWQCP totaling \$4,500 for outreach and education

Promoting Existing LSC Partner Programs and Priorities

- Working with Barbara to create outreach materials for partners to promote the WBIF nonstructural ag BMP policy
- Working with Barbara to create agricultural services and program offerings provided by the partners
- Created and distributed a mailing to promote Chisago SWCD & NRCS's programs and technical services available
- Created information for a news release of the WBIF non-structural ag program
- Completed 6 site visits in Washington County, 1 in Pine County, and 1 in Chisago County
- Providing watershed farmers with conservation planning and support for local and federal programs
- Providing partners with conservation planning support and education
- Completed conservation planning on 4 WBIF non-structural ag BMP program applications and encumbered 3 contracts

Development of New Programs

- Developed the WBIF non-structural ag BMP policies and worked with partners to integrate into their local program policies
- Secured a Clean Water Fund Soil Health grant for \$200,000 for implementing soil health practices, outreach, and education
- Working with partners to develop agricultural cost share policies
- Invited to participate in the Minnesota Soil Health Action Framework Stakeholder Cohort to assist in the development of the Minnesota Soil Health Action Framework
- Working with Angie, Barbara, Peterson's Mill, Big River Farms, and the University of Minnesota to develop a program to work with the Hmong community providing agronomic information and resources
