Summary of potential projects for FY22-23 WBIF supplemental funding request:

• Anoka Conservation District:

- Requesting funds to install shoreline stabilization and restoration projects on at least 300 linear feet of shoreline, focused on LSC priority lakes including Linwood and Martin, resulting in 8 lbs/yr phosphorus reduction minimum. This work would help meet LSC Partnership goals for developed and developing areas (actions 20 and 21 in table 5-1) of 20 lakeshore stabilizations and restorations per year.
 - \$35,000 grant funds requested for technical / engineering support
 - \$100,000 grant funds requested for project implementation (\$13,500 match)
 - Total grant funds requested \$135,000

• Carnelian – Marine - St. Croix Watershed District

 - \$375,000 grant funds requested to implement targeted enhanced street sweeping plans in Scandia and Marine on St. Croix

• Comfort Lake – Forest Lake Watershed District
